Code, MICR code of the Nationalized Bank, Mobile Number, E-mail ID & Pan Card No.**

Repairing of Central AC Machine shall be within 3-days from the date of receipt of the repairing order failing which the repairing order shall be rejected at the risk and responsibility of the supplier and he shall not be entitled to any compensation.

All the information, as called for in the quotation call notice, should be submitted truly, clearly, legibly, transparently, unambiguously and without the use of abbreviation.

There should be no over-writing in the quotation paper submitted or other papers submitted. All additions, alterations, deletions, cuttings, corrections etc. should be indicated and rubber stamped (or seal) by the same person, who signs the quotation, failing which the quotation may be rejected.

Submission of more than one competitive bid/quotation by the same firm in response to the quotation call notice is prohibited. All such bids/quotations except one will be cancelled at the discretion of the authority calling the quotations/bids.
